**Narcotic Analgesics: An Overview and Update** –Describe the pharmacology and pharmacokinetic of the opioid analgesics; Discuss pharmacogenomic considerations for opioid use; Identify clinical pearls for the commonly used opioids; Review different dosing strategies used for opioids including initiation, titration, maintenance and termination techniques; Design a pharmacotherapeutic plan for a patient in chronic pain.

**Real Drugs in the Virtual World: the Internet, Drug Misuse, and the Pharmacist** - Describe how the virtual world influences real-world drug use; Identify and assess websites of drug use, their quality of information, and their ideological stance with regard to drug misuse; Determine the extent of drug misuse as portrayed in the electronic world; List and describe specific strategies pharmacists can use to prevent drug misuse in participants of the electronic world.

**New Hampshire Law Review 2010**- Provide an update on legislative information on both federal and New Hampshire laws and regulations; Discuss practitioner prescribing laws for controlled substances; Describe the prescription label requirements; Relate a law concept to different practice situations and describe the effect of certain laws on the individual practice.
