## HOUSE CALENDAR

### MEMBERS OF THE HOUSE:

First, and foremost, I want to condemn in every possible way, the violent and destructive riots that took place in Washington, D.C. on Wednesday. America should be an example to the rest of the world for peace and order, even in times of disagreement. What we saw unfold on Wednesday was a barbaric assault on what our founding fathers had intended for our Great Nation. Please join me in praying for those who lost their lives and those members of law enforcement who put their lives on the line protecting our institutions. This was a senseless and tragic event for our nation, and I hope that we can all move forward from this with a better appreciation for each other despite political differences.

I'd like to thank all of you for your patience and participation in our UNH session on Thursday. This was truly a first of its kind event, and we couldn't have even begun to imagine it was possible if it weren't for the ingenuity and perseverance of the General Court staff and the UNH staff.

I'd also like to extend my sincere appreciation to you for entrusting me with holding the office of Speaker. After serving over 30 years in the legislature, I hope my experience and my loyalty to this historic body will be of some benefit in these challenging times. I look forward to working with you, and just as my predecessor and friend Dick Hinch said, my door will always be open.

We know we won't be blessed with sunshine and temperatures in the mid 30's on every winter day, so we are keeping our options open for how the House will meet next. I appreciate your understanding that we need to be good stewards of taxpayer dollars, and we can't rush to make expensive, permanent solutions to what we hope is a temporary problem. We will continue working with staff to develop plans for several possibilities for our next session, and sessions forward into our 2021 schedule.

Seating assignments are included in this calendar. Although I can't guarantee when you will be actually sitting in these seats, this is a tradition of the House. I hope you get to know your seatmates in safer times.

Some policy committees will be holding virtual/remote orientation meetings in the coming weeks. Please pay attention to the schedule and your email inbox for information on how to participate in those meetings.

Many of you have reached out to me about how to acquire your General Court license plates. We have worked on a solution with the Division of Motor Vehicles to help minimize the need for both you and their staff to interact in-person.

Legislative cover plates will be distributed by mail this year. Each of you will receive a form from the Division of Motor Vehicles. Forms are sent directly to Representatives for verification, signature and payment. Representatives will then return these forms via the included prepaid envelope. The DMV will process payment, and scan the forms. The forms are then mailed with the plates to the Representative.

You are entitled to two sets of plates at \$9 per set. You will need to indicate how many sets you want. If you have a title and prefer that, please specify whether you want number plates, title plates, or one set of each.

They hope to get number plates out as soon as possible. Keep in mind that due to staffing problems at the prison, there could be a delay on some plates, including leadership/title plates. The list of Representatives names and addresses will be received by DMV early next week and they will begin sending you your forms.

As a reminder, state offices will be closed on Monday, January 18th in observance of Martin Luther King Jr. / Civil Rights Day.

### NOTICE FROM THE ADMINISTRATIVE OFFICE

On 12/22/2020, the Internal Revenue Service modified the standard mileage rate for transportation expenses. For 2021, the federal mileage reimbursement rate for members of the General Court decreases from \$0.575 per mile to \$0.56 per mile for all miles incurred on or after January 1, 2021. Mileage checks dated January 15th are for the period of 12/2/2020 through 12/21/2020 at the previous rate. Going forward the new rate will apply.
